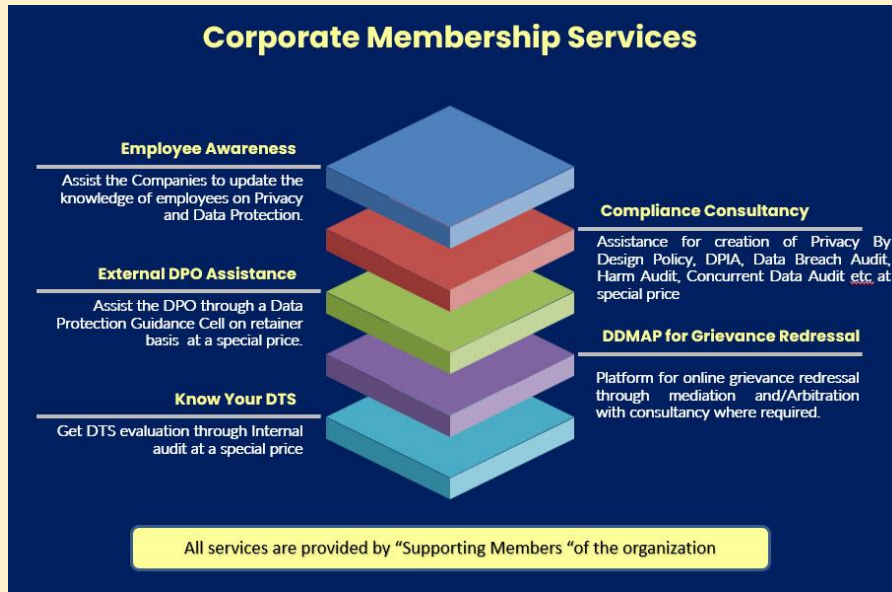

# Be a Corporate Member



FDPPI provides many services to Companies and Government organizations engaged in the processing of data. Emphasis of all services are "Privacy Protection as required under the data protection laws". Corporate members are eligible to get all services at a discounted rate. Apart from the services available for individuals all of which would be made available to the employees of a Corporate entity at special rates, several services are provided directly to the organizations.

External DPO assistance and Personal Data Governance Guidance and "Data Disputes Mediation and Arbitration" (DDMAP) is made available for companies to support their internal personal data protection governance system.

FDPPI offers the DPCSI (Data Protection Compliance Standard of India) framework as a Unified open standard to enable simultaneous compliance of multiple data protection laws and compliance of Data protection laws for both personal and non personal data. DPCSI incorporates the best global privacy principles and is the only framework that incorporates "Data Trust Score" (DTS) as part of the assessment program. Organizations can self-implement DCPSI or use the services of accredited consultants and auditors ensure that they remain compliant.

## Membership Fee

The Corporate Membership fee is a onetime fee based on the number of individual members to be assigned under the membership and not on the basis of turnover. The minimum fees is Rs 18000/\* under which a company can assign three subordinate members to avail of the benefits available to the personal members. If the Company wants to enrol more members, the fees will be higher by Rs. 6,000/- \*for each additional member beyond the first three members. The members may be replaced on an annual basis if required. (\*subject to change)
